Concerns raised regarding potential noise due to proposed pickleball facility in Magnuson Park.

Friends of Magnuson Park – Historic District Signage Proposal

Elisa Law, Executive Director – Friends of Magnuson Park, delivers presentation regarding proposal for Art Deco signage on the west façade of Building 138.

- De Abreu presents existing and ongoing efforts to address safety issues.

Seattle Parks Updates	Budget issues: The City's hiring freeze continues and the normal team of 4 at Magnuson Admin Office is currently a team of 2 staff. We appreciate your understanding as we prioritize tenant operations work and put other projects on hold as we navigate this hiring freeze. Tenant renewals March-May 2025: 24 Artists Tenant Improvements: Sail Sand Point starts Phase I of its tenant improvements to remodel the former weld shop in Building 11. Project begins April 1, 2025, estimated 4 weeks of work. Magnuson Theater: post-fire restoration is 98% complete.
