#### **Reminder: LOC Purpose**



Monitor revenues, expenditures, and program and project implementation



Advise the City Council, the Mayor, and SDOT on responding to program and project cost savings or overruns



May make recommendations to the Mayor and City Council regarding the spending of Levy Proceeds



Annually review SDOT's program and project priorities, spending, and revised financial plans



#### Levy Portfolio Status Update Background



#### 2015 Ordinance and 2018 Workplan Update Targets

- 2018 Workplan Update Report developed following assessment which found that some subprograms lacked sufficient funding to deliver on voter commitments
- <u>2018 Workplan Update</u> also introduced numerical targets in some programs that did not have specific numerical deliverable goals in <u>2015</u> <u>Ordinance</u>

 ✓ Work with the Levy Oversight Committee, SDOT Race and Social Justice Change Team, Transportation Equity Workgroup, and staff to ensure Levy resources continue to **advance opportunities in BIPOC communities and minimize harm** during the remaining years

✓ Make equitable, strategic, and targeted investments to prioritize funds to meet our 2018 work plan goals, reprioritize funds to projects that make progress on our 2015 levy deliverable goals, and support our citywide Vision Zero, equity, climate and asset management goals

✓ Strive to advance capital projects and **allocate levy funds** before 2025

 ✓ Work with stakeholders on a financial framework and strategy to determine which capital projects to prioritize if new funds are to materialize

### SDOT 2023-2024 Proposed Budget

#### **Priorities:**

- •Finish strong on the Levy to Move Seattle
- Fund core services sustainably
- Continue to invest in Vision Zero
- Implement Transportation Equity Framework



### Finishing strong on the Levy to Move Seattle

In **addition** to the baseline budget, in the 2023-24 Proposed Budget we are:

1) Investing available Levy and non-Levy funds into **specific programs** previously identified as at risk for not meeting 2015 Ordinance goals, **getting us on track** to meet or get closer to 2015 Ordinance goals

2) Continuing to invest available Levy and non-Levy funds across the portfolio, allowing us to *stay on track* to meet 2015 Ordinance goals

The 2023-2024 proposed budget works in tandem with other budget actions we take, such as supplemental budget actions and administrative transfers.

# 2) Across the portfolio, allowing us to stay on track to meet 2015 Ordinance Goals

Program	Funding	Projects Supported
1 – Safety Corridors	<b>STM -</b> 2023: \$1.4M	Safety improvements along High Injury Network streets.
2 - Safe Routes to School	<b>SSTPI -</b> 2023-2024: \$0.4M	Projects to create safer places to walk and bike on routes to schools, including improvements on busy arterial intersections like curb bulbs and flashing lights, speed humps for neighborhood street calming, and stop signs to improve traffic control.
18 - Multimodal Improvements	<b>REET -</b> 2023: \$2.9M	Burke Gilman Trail
26 - SPU Broadview	<b>SSTPI -</b> 2023-2024: \$0.4M	Projects to increase pedestrian safety in the Broadview neighborhood.
27 – Bike Parking and Bike Spot Improvements	<b>SSTPI -</b> 2023-2024: \$0.5M	Projects to increase safety on bike routes.

## Legislation as part of 2023-2024 Proposed Budget

Two pieces of relevant legislation:

- Transportation Network Company (TNC), a.k.a. "Rideshare," revenues no longer overseen by LOC
- Material change to Seattle Transit Measure: increase to cap in annual capital spending


#### Additional Funding in Bicycle Safety - \$19.3M Resulting from Levy Portfolio Status Update work

#### • 2023-2024 Proposed Budget

- Levy \$11.8M to Protected Bike Lanes (\$11.6M) and Neighborhood Greenways (\$0.2M)
- SSTPI \$1.9M to Neighborhood Greenways
- Administrative transfers
  - \$1.8M to Neighborhood Greenways
- Supplemental budget actions
  - \$3.8M to Protected Bike Lanes


#### 1) Finish Strong


- Build new protected bike lanes & trails (14.25 miles)
- Build new neighborhood greenways partnering with Safe Routes to School (14.59 18.09 miles)
- Build permanent Healthy Streets on existing neighborhood greenways built under the Bridging the Gap Levy (2.7 9.5 miles)
- Turn some temporary Healthy Streets into permanent Healthy Streets (3.1 miles)


#### **Protected Bike Lanes and Trails**







### **Neighborhood Greenways**



### **Program 9 - Arterial Roadway Maintenance**

#### **Additional Funding in Paving Projects - \$16.2M** Resulting from Levy Portfolio Status Update work

#### • 2023-2024 Proposed Budget

- Levy \$10.7M to Arterial Asphalt & Concrete
- Levy \$1.3M to Arterial Major Maintenance
- Levy \$0.3M to E Marginal Way (paving components)

#### Administrative transfers

- Levy \$1.3M to Arterial Major Maintenance
- Levy \$0.9M to Arterial Asphalt & Concrete

#### Supplemental budget actions

- REET- \$1.3M to Arterial Asphalt & Concrete
- Levy \$0.4M to Central Waterfront (Alaskan Way paving)



### **Program 9 - Arterial Roadway Maintenance**

- Capitalize on partnership opportunities on projects like Alaskan Way and East Marginal Way to deliver paving mileage funded by the Levy
- Secure new funding to deliver additional paving mileage

## **Program 12 - Bridge Seismic**

- Completing concept design reports (CDRs) for seismic retrofits for 7 bridges, outside of the original list of 16 bridges
- From that list, will select 3-5 bridges to complete seismic retrofits on pending available funding
- Will continue to identify additional funding opportunities for the Bridge Seismic program
